

Privacy Notice for California Consumers

This Privacy Notice for California Consumers supplements the information contained in Astex's Privacy Notice (<https://astx.com/privacy-policy>) and applies solely to natural persons who are California residents ("consumers" or "you"). Astex Pharmaceuticals, Inc. ("we" or "Astex") adopts this notice to comply with the California Consumer Privacy Act of 2018 ("CCPA") and its amended act, the California Privacy Rights Act ("CPRA"). Any terms defined in the CCPA/CPRA have the same meaning when used in this notice.

Personal Information We Collect

Where not prohibited by the CCPA/CPRA and required to support our business relationships or provide our services, we may collect the following personal information, including sensitive personal information, that identifies, relates to, describes, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular employee, consumer or household ("personal information"):

- Identifiers such as SSN and driver's license number;
- Financial, medical, or health insurance information;
- Demographics;
- Internet or other electronic network activity information;
- Professional information;
- Education information; and
- Inferences regarding preferences or other characteristics.

Sources

We may collect personal information from the following categories of sources:

- From your device or browser
- Directly from you when you provide information
- From our affiliates and business partners

How We Use the Personal Information Collected

We may use the personal information we collect for purposes such as:

- Providing you products and services
- Addressing your inquiries, concerns, and requests

- Analyzing use of our products and services and improving our products and services
- Developing new products and services
- Providing and personalizing our offers and services
- Maintaining the security of our services
- Complying with legal obligations
- Protecting our or the rights, property, and safety of others

Whom We Share Personal Information With

We may share the personal information we collect with:

- Our vendors and service providers
- Our affiliates and business partners
- Law enforcement, where required by law

We may also share personal information with other companies, organizations or individuals outside of Astex if we have a good faith belief that access, use, preservation, or disclosure of that information is reasonably necessary to:

- Meet applicable laws, regulations, legal processes or enforceable governmental requests
- Enforce applicable Terms of Service, including investigation of potential violations
- Detect, prevent, or otherwise address fraud, security or technical issues
- Protect against harm to the rights, property or safety of our users, Astex, or the public as required or permitted by law
- Engage in a merger, acquisition, reorganization, or sale of all or a portion of Astex assets.

Categories of Personal Information Shared

The following categories of your personal information may be shared with these parties for our business purposes:

- Identifiers;
- Demographics;

- Internet or other electronic network activity information;
- Professional information;
- Education information; and
- Inferences regarding preferences or other characteristics.

Sale of Personal Information

Astex does not sell, rent, release, disclose, disseminate, make available, transfer, or otherwise communicate personal information to another business or a third party for monetary or other valuable consideration except as may be permitted by CCPA/CPRA.

Your Rights

California law provides California residents with the following privacy rights:

- **Right to access personal information:** Users exercising this right may request access to the categories and specific pieces of their personal information we hold.
- **Right to rectification:** You may request correction of any inaccurate, incomplete, or out of date personal information we hold on you.
- **Right to data portability:** Users exercising this right may receive their personal information, when provided electronically, in a readily-useable format.
- **Right to deletion:** Users exercising this right can ask us to delete their personal information we have collected.
- **Right to disclosure:** Users exercising this right can receive additional information regarding the sources from which we collect information, the purposes for which we collect and share personal information, the information of theirs we hold, and the categories of parties with whom we share their information.
- **Right to limit use and disclosure of sensitive personal information:** You can request limitations on the use and disclosure of your sensitive personal information at any time.
- **Right to opt-out of sales:** Astex will not share your personal information for monetary or other valuable consideration (a "sale"); however, if we did, users could exercise this right and direct us to stop selling their personal information.

- **Right to be free from discrimination:** Users may freely exercise these rights without fear of being denied goods or services. We may, however, provide a different level of service or charge a different rate reasonably relating to the value of your data.

Exercising Your Rights

If you are a California resident, you may exercise any of your rights described above by submitting a verifiable request to us via our [Privacy Web Form](#) or contact us at dataprivacyUS@astx.com or at 1-877-223-1841.

You may only make a verifiable request twice within a 12-month period. The verifiable request must:

- Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative of that person.
- Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it.

Please note that we may require additional information from you in order to honor your request, and there may be circumstances where we will not honor your request, as permitted under the law. If we cannot verify your identity or authority to make the request and confirm the personal information relates to you, or California law otherwise provides an exemption to us, we may not fulfill your request and will inform you of that outcome.

We will only use personal information you provide us in a verifiable request to verify your identity or authority to make the request.

Changes to Our Notice

We reserve the right to amend this Privacy Notice for California Consumers at our discretion and at any time. When we make changes to this Privacy Notice for California Consumers, we will post the updated notice on the website and update the notice's effective date. Your continued use of our website following the posting of changes constitutes your acceptance of such changes.
